



## CERTIFICATE OF AGREEMENT BETWEEN

### Faculty of Mathematics and Natural Sciences UNIVERSITAS BENGKULU AND Kurnakov Institute of General and Inorganic Chemistry of the RUSSIAN ACADEMY OF SCIENCES

With the objective of strengthening their mutual cooperation as well as striving for the promotion of mutual exchange between **FACULTY OF MATHEMATICS AND NATURAL SCIENCES, UNIVERSITAS BENGKULU, Indonesia** (hereinafter referred to as "**FMIPA - UNIB**"), having its address at Jl. W.R. Supratman, Kandang Limun, Bengkulu 38371 A, Indonesia, and **KURNAKOV INSTITUTE OF GENERAL AND INORGANIC CHEMISTRY, RUSSIAN ACADEMY OF SCIENCES** (hereinafter referred to as "**IGIC RAS**"), having its address at 31 Leninsky ave., Moscow 119991, Russia, have concluded the following intentions :

1. Both parties agree to exercise their best efforts to develop the following forms of collaboration:
  - i. development of research and publication;
  - ii. jointly organizing conferences, seminars, workshops and forums;
  - iii. exchanging and sharing of expertise;
  - iv. sharing and use of resources and facilities subject to terms and conditions;
  - v. agree to provide student database in the best practice without jeopardizing and breaching the existing policies to promote articulation and progression of programs in the future; and
  - vi. any other areas of collaboration maybe mutually agreed by both parties.



2. The terms of the specific areas of agreement shall be further considered and agreed upon in writing by the Parties prior to the initiation of any particular activity.
3. Any specific program will be subject to mutual consent and approval by both parties.
4. This Certificate of Agreement will be effective when both Parties have signed this certificate and shall remain in force until terminated by either Party giving the other party six (6) months in advance.
5. The provisions of this Certificate of Agreement may be amended at any time by the mutual consent in writing of both Parties.
6. The Parties agree that this Certificate of Agreement is not a formal legal agreement giving rise to any legal relationship, right, duties or consequences, but it is only a definite expression and record of the purpose of the Parties to which the Parties are bound in honor only.
7. The implementation of this Certificate of Agreement shall be constructed and governed in accordance with Laws of Russian Federation and the Laws of the Republic of Indonesia
8. Ultimate responsibility for this Agreement lies with Dean/Director of each institution.
